Auditors' Code of Ethics

4. Principles of Competence, Objectivity, and Rigor

I guarantee possessing the necessary technical and scientific skills to meet RESCUE standards. I commit to acting with objectivity, professional rigor, and impartiality throughout all stages of the audit process.

5. Principle of Confidentiality

I will strictly respect the confidentiality of all data, approaches, and results obtained during the audit. I will maintain professional secrecy and refrain from providing third parties access to software applications, databases, or documentation related to the audit. Upon completion of the process, I will destroy all documentation and data in my possession and will not retain or use any information for personal or external purposes.

I will not accept, receive, or solicit gifts, benefits, or favors that could influence my performance or compromise the integrity of the audit process.

8. Integrity and Prestige of RESCUE

I will act at all times safeguarding the integrity and reputation of RESCUE, responsibly representing the values of the organization.



9. Limitations on Interactions

During the audit process, I will refrain from discussing personal experiences, offering suggestions, or advising on how to proceed within the audited areas. My role will be strictly limited to evaluating compliance with the established standards.
